

National Treasurer's Report

Submitted to the Annual General Meeting, held 2nd December 2022

Summary

- This report covers the dates: January 2021 to December 2022.
- Predicted expenses for 2023: \$997.60.
- The current position of the Business Transaction Account (Accessible by National Executive) (Branch No. 162 000, Account No. 1643 6980): \$1,140.51.
- Transactions on the Business Transaction Account **A** are itemised, beginning on Page 3.
- The current position of the Business Transaction Account B (Accessible to Treasurer- QLD Branch) (Account ending #2799) : \$8,000 (to be updated)
- Memberships: 2021 15 paid members; 2022 18 paid members (including institutional members).
- Remittances owing to the Chapters: \$542.50. These were distributed by the Treasurer QLD Branch from the Business Transaction Account **B** on December 6, 2022.
- The 2022 Biennial Conference incurred minimal expenses.
- Ruth McConchie and Romany Manuell made several unsuccessful attempts to have the Business Transaction Account **A** transferred from the previous office bearers over the course of 2021 and 2022. For future reference, we will attach the statement from the Commonwealth Bank in relation to the transfer of unincorporated organisation financial accounts at the end of this report. Business Transaction Account **A** was finally transferred to Ruth and Romany on November 9, 2022. Business Transaction Account **B** was not transferred to the National Executive and remains accessible to the Treasurer- QLD Branch.

2022 Biennial Conference

The 2022 Biennial Conference was inexpensive to run but required a lot of unpaid labour by the

National Executive and in-kind support from the University of Melbourne. The only cost for the conference was the engagement of two artists as guest speakers. The artists were paid at the NAVA rate for artist talks (\$457) plus \$43 for incidentals.

Due to the on-going global pandemic, the limited finances in the National Executive Business Transaction Account A, the marked decrease in professional development resources in libraries and the high cost of living, the National Executive decided to run the conference at no cost to participants. This resulted in the 2022 Biennial Conference running at a loss of \$1,000. We believe this online model increases the accessibility, safety and sustainability of the conference.

Notes regarding the transfer of accounts at Commonwealth Bank

As mentioned in the summary of this Treasurer's Report, Ruth McConchie and Romany Manuell made several unsuccessful attempts to have the Business Transaction Account **A** transferred from the previous office bearers over the course of 2021 and 2022. For future reference, the minutes of any future meeting must use the following wording:

"As discussed, the authority on our Commonwealth Bank accounts ending in #6980 and #2799 will be changing, [Party 1 and Party 2] to be removed and replaced by [Party 3 and Party 4]. The method of operation will be two to sign."

In addition, these minutes must be signed by the Chair of the National Executive in "wet ink". That means, it is insufficient to produce a document, scan it, and email it. The Commonwealth Bank must see the original signature, rather than a scan.

Business Transaction Account **B** has not been transferred to the National Executive but remains accessible to the Treasurer- QLD Branch. As the National Executive will shortly be transferred to NSW or QLD this will be transferred directly to the incoming National Executive.
