Executive summary:

Arlis/ANZ ran at a loss for the financial year 2022-23. Total loss was \$1642.49

There are two National accounts. Current balances as at 21 November 2023:

Arlis Visa Debit \$1,703.26 Arlis Working Account \$6,339.29

Membership fees are paid into the Arlis Visa Debit account. Disbursements to Chapters for the 2021-22 financial year were made in December 2022. Disbursements for the 2022-23 financial year were made in July 2023 and will be accounted for in the 2023-24 financial year report.

Total membership income was less than \$1000, with half being disbursed to Chapters. Therefore, National income from memberships was less than \$500.

At the current rate of income [largely membership fees and copyright royalties] and expenditure [largely website hosting costs and Chapter reimbursements], and without additional income from profit-making conferences, current funds will be depleted in approximately four and a half years.
